4 Applying for a Family Discount

- Tick the category of the applicant's family discount
- If selecting "1. Student", insert the student ID number, expected year of finishing and current grade
- Tick the applicant's method for confirming cohabitation at the family address
 *If selecting "3. Student ID", insert the student ID card number
 *If selecting "4. company ID or health insurance certificate", insert the name of the applicant's employer (company name) and the address of the applicant's temporary place of work
- In "the parent/family home etc." section, insert the name, address and phone number of the parent/family home etc. contract holder with whom the applicant usually cohabits
 *When applying for a family discount for a second home, insert the address of the applicant's primary home.
- In "② The Applicant's Name and Address", insert the name of the student, person working away from home etc, who is applying for the family discount

NHK The Receiving Fee System

NHK is funded by the receiving fees. They make up about 96% of the corporation's total income.

The receiving fee system ensures NHK's financial independence, which guarantees NHK's editorial independence and impartiality.

NHK's mission as a public service media organization is to deliver impartial, high-quality programs. Programs should never be influenced by the government or private organizations. NHK considers it to be its responsibility to provide a wide range of programs that are balanced, without the influence of ratings or third-party interests.

NHK was established under the law as the Japanese public broadcaster. Every household and business that has a TV set or other device capable of receiving NHK's domestic broadcasts, or has begun using NHK's online services, is required to enter into a contract with NHK and pay the receiving fee, regardless of nationality.

We do not ask to pay for access to specific programs, but rather to support the operations of NHK as a whole.

The Broadcasting Act stipulates that every household and business having a receiving device or receiving NHK's domestic online service is required to enter into a receiving contract.

In what case is a receiving contract required?

Anyone who has installed a device capable of receiving NHK's domestic broadcasts, such as a television, or start receiving NHK's domestic online service called NHK ONE (excluding radio-related services) is required to pay the receiving fee by entering into a contract with NHK.

Devices capable of receiving NHK's domestic broadcasts

TV

PC with a TV tuner

Smartphone with One Seg function and the like

Car navigation system with a TV tuner

In the case in which only a radio is installed, a receiving contract is not required.

NHK's domestic online service called NHK ONE

Website

Apps

If your household already has a receiving contract, no separate contract or additional fee is required.
(A receiving contract is not required for radio-related services such as RADIRU★RADIRU.)

Before you start using the service by accessing the above website or any of the apps, you must complete a required step to confirm that a receiving contract is necessary. (Ownership of a smartphone or PC alone does not require a receiving contract.)

What types of receiving contracts are required?

There are two kinds of receiving contracts.

The Terrestrial Contract
(terrestrial broadcasts · internet)

The Satellite Contract
(satellite + terrestrial broadcasts · internet)*

A terrestrial contract is required if your television set can only receive terrestrial broadcasts or if you start using NHK's domestic online service.

A satellite contract is required if your television can receive satellite broadcasts.

*Those who have a TV set or any other device capable of receiving satellite broadcasts are required to make a satellite contract, even if they have started receiving NHK's domestic online service.

How much is the receiving fee?

※Even if you do not have a TV set or similar devices, a terrestrial contract is required if you start using NHK's domestic online service.

Payment can be made at intervals of 2, 6 or 12 months.

Discounts apply to the 6 and 12 monthly payments.

How can I pay the receiving fee?

You can pay by:

- ① Credit card
- ② Bank transfer
- ③ Payment slip

You can pay by credit card or directly from your Japanese bank account. Alternatively, you can pay at banks, post offices or convenience stores by using the payment slips posted to your address.
